

CITY OF ROCKY FORD - CITY COUNCIL MEETING

April 27, 2021

WORK SESSION: 6:00 p.m.

Mayor Jung, Councilmembers Peggy Sue Corbin-Romero, Larry Herrera, Cuco Ruiz, Sherri Cordova, Daryl Grasmick, Rich Geist, City Manager Shannon Wallace and Economic Development Coordinator Marty Lee (by Zoom) met for work session. Discussion was held regarding the lease agreement between the City of Rocky Ford and the Rocky Ford Country Club Board. Fred Grantham gave Council a report on the progress of the remodel at the golf course. Carola Hagenau informed Council that she had met with the golf board and had presented a plan to run a restaurant or possibly purchase the building. The golf board reported that they are nowhere near the ability to be able to rent the building out at this time as they are still in the process of cleaning. The Board's focus is the renovation and getting the clubhouse and pro shop open. Much discussion was held regarding the current contract and the need to have an updated contract prepared.

PUBLIC COMMENT

Carola Hagenau gave Council additional information regarding her proposal to the Rocky Ford Country Club Board and asked Council if they would be interesting in selling the building if an agreement cannot be made with the Country Club.

CITY MANAGER'S REPORT

City Manager Shannon Wallace had previously emailed her report to Council. In addition, she reported on the following:

- Library board had a meeting and the bylaws were changed to include no term limits for board members.
- Shannon suggested that Council consider an Intergovernmental Agreement with the Rocky Ford Fair Board.
- Chamber of Commerce has requested that the City replace a broken window. Shannon mentioned that maybe an
 invitation to the Chamber Board to attend a work session would be helpful.
- The new building on Willow was constructed with all the proper permits and has met code requirements.
- Shannon is trying to get UNCC boundaries for the City.
- Shannon and Azucena are working on the new ADG software conversion.
- Valley Wide Health Services would like to build on to their current building or build a completely new building. They
 would like to apply for a grant and have asked Council to allow them to use the City as a pass through for the
 Community Development Block Grant (CDBG).

MAYOR AND CITY COUNCIL REPORTS

Mayor Jung reported that the new estimate to complete the three rooms at the Public Safety Building is now \$80,633.34. It was the general consensus of Council to pay the bill as long as it doesn't exceed the approved amount. The Colorado Municipal League is going to have an "in person" summer meeting in Westminster and Mayor Jung is not certain at this time what the costs will be to attend but she will provide further information at a later date. The Fire Pension Board met and they completed their bylaws and they've been sent to City Attorney Nathan Shultz for review.

Councilmember Herrera reported that since the clubhouse is not open yet, the golf course is using a box to place money in, on the honor system, to pay for playing golf.

Councilmember Grasmick commented that there is no water in Holbrook Lake and reminded everyone how important water conservation is to us all.

Councilmember Cordova reported that she will attend the Chamber of Commerce Board meeting on May 6, 2021

Councilmember Corbin-Romero informed everyone that she had received a call from David Kline. Mr. Kline wants to give the Tree Board a donation from the Rocky Ford Garden Club that has disbanded.

Councilmember Ruiz asked when the City would be activating the sprinklers. Councilmember Grasmick reported that there is a triangle at the end of Hopkins and Franklin Streets that needs to be mowed if it belongs to the City and also that the cemetery is not being watered properly as the sprinklers go around in a circle and the cemetery lawn is rectangular so all four corners are not getting water. Mayor Jung asked if the exterminator had been out to the cemetery to check on the gophers and she also reported that there is a U.S. flag at the cemetery that needs to be replaced.

Both parties are now ready to sign so the Mayor asked Council to allow her to sign on behalf of the City. Councilmember Grasmick moved to allow Mayor Jung to sign the mutual aid agreement between the City of Rocky Ford and Otero County. The motion was seconded by Councilmember Geist.
