

## CITY OF ROCKY FORD – CITY COUNCIL MEETING

## **December 12, 2023**

WORK SESSION: 6:00 p.m.

City Manager Shannon Wallace, Police Chief Sean McDonagh, Police Captain Carol Coates, Code Enforcement Officer Natasha Ortiz, Mayor Duane Gurulé, Councilmembers Nicole Roberts, Nicholas Martinez and Sherry Cordova met to discuss city ordinances regarding right-of-way permits, commercial vehicles on residential streets and abatement of dangerous buildings or structures and to discuss a possible proposed resolution for non-compliance of vacant building code and possible changes to the city fee schedule.

## PRESENTATIONS, AWARDS, PROCLAMATIONS

Presentation by Sarah Dillon, Tri-County Family Care Center Presentation by Donna Hunt, Valley Wide Health Clinic Oath of Office – Sherry Cordova Councilmember Ward I

Sarah Dillon with Tri-County Family Care Center thanked Council for the opportunity to inform the public of all the services they provide. Dillon went on to give more detailed information regarding help available to families and children. Dillon provided pamphlets with information that can be given out to the public. Dillon thanked Council for their continued support of Tri-County's money-making projects. Dillon asked Council to allow the city and Tri-County websites to be linked.

Robert Barron informed Council that he had talked to Donna Hunt with Valley Wide Health Clinic. Barron expressed that the last quarter of the year is very stressful for people. Barron reported that Valley Wide Health Clinic has many resources to help people and encouraged people to reach out.

City Clerk Rebecca Korinek administered the oath of office to Sherry Cordova, Councilmember Ward 1. Cordova was not able to be present at the last regular meeting when Gurulé and Roberts were sworn in. Cordova gave thanks to all and expressed her pleasure of being able to meet the public while trying to get donations for Christmas lights.

#### STAFF REPORTS

City Manager Shannon Wallace had previously submitted her report by email, but added the following:

- Christopher McCrary, 605 Bowen, reported that a big tree has caused damage to the water meter, sidewalk and other things. Public Works Director Rick Long went to inspect the situation. The customer is willing to pay for one-half of the cost of the tree removal if the City of Rocky Ford will pay the other one-half. Since the tree is causing damage to City property, the City Manager recommends that the City of Rocky Ford pay for one-half. It was the general consensus of Council to authorize the City Manager to get a few bids for the tree removal and to go ahead with the removal.
- Wallace is ready to prepare an RFP for the work needing to be done on Sycamore.
- Wallace reported that Christmas cards are being sent out. Since Councilmember Sherry Cordova worked on getting
  donations for Christmas lights, Wallace asked if Councilmember Cordova had any recommendations for Christmas cards.
- SBT came to City Hall and put in three (3) new circuits so that electric heaters could be used until the heating is fixed.

Mayor Gurulé recessed the regular meeting at 7:29 p.m. and opened the public hearing. The public hearing is being conducted to inform citizens and to solicit public input, either written or oral, regarding the City of Rocky Ford's 2024 budget. Mayor Gurulé closed the public hearing and reconvened the regular meeting at 7:30 p.m.
