### **CITY MANAGER'S REPORT**

City Manager Shannon Wallace reported on the following:

• City Manager Wallace gave Council spreadsheets containing information for all the city funds for the proposed 2022 budget. The spreadsheets were also sent to the City Auditors. Some discussion was held.

 Shannon requested that Council approve her to pay Christmas bonus' to employees this year. Councilmember Gurule moved to allow City Manager Shannon Wallace to pay out Christmas bonus' (Option 1) to City employees. The motion was seconded by Councilmember Cordova. Voting results were:

• Shannon asked that Council approve her to have a Human Resource audit conducted for approximately \$5,000, to audit personnel files and policies and procedures manual. This money would come from a dividend from Pinnacle Worker Compensation. Councilmember Gurule asked that City Manager use some of the dividend money to allow employees to attend trainings or certifications. Councilmember Gurule motioned to allow an HR audit for approximately \$5,000 and allocate \$27,000 for professional development for the employees of the City of Rocky Ford. The motion was seconded by Councilmember Geist. Voting results were:

### MAYOR AND CITY COUNCIL REPORTS

Mayor Jung thanked the seated Councilmembers and she commented that she is looking forward to the coming year. Mayor Jung read aloud a thank you note received by the Rocky Ford School Board for Council's support of the school bond initiative. Mayor Jung reported that she will attend the Colorado Municipal League (CML) executive board meeting on December 10<sup>th</sup> in Denver. Mayor Jung reported that an email was received from J. R. Thompson giving praise to Officer Enrique Guzman.

City Manager Wallace commented that she will be awarding Officer Guzman with an "Employee of the Month" award.

Councilmember Geist had nothing to report.

Councilmember Cordova reported that she attended the Library Board meeting. The Library Friends purchased five (5) computers for the library. Stacey Milenski was informally appointed to the Library Board. Cordova mentioned that there was some discussion regarding an emotional support animal that may or may not be allowed to be in the library.

City Manager Wallace commented that she, City Attorney Nathan Shultz and Library Director Leanna Chavez are looking into the matter. Councilmember Herrera suggested that someone should seek guidance from the Government regarding the American Disabilities Act.

Councilmember Cordova asked Council to remove her from attending the Chamber of Commerce Board meetings. Cordova has been unable to attend the meetings due to personal obligations.

Councilmember Gurule reported that the Small Town Project hosted a Thanksgiving meal share, 150 turkeys and full dinners were distributed to people from Rocky Ford, La Junta, Swink, Manzanola, Crowley County, Las Animas and Boone. Gurule attended the Veteran's Day program held by the 2<sup>nd</sup> grade class at Washington School. Gurule noticed some orange tags on abandoned vehicles and thanked Code Enforcement Officer Natasha Ortiz for her work. Gurule received some calls or reports regarding feral cats and dogs running loose and he asked what could be done.

City Manager Wallace commented that all calls should go through the Dispatch Center so that calls can be directly routed to Code Enforcement. Gurule took the opportunity to thank the Public Works Department and Black Hills Energy for getting the Christmas decorations up.
