J.R. Thompson advised Council that the Rocky Ford Planning Commission will be conducting a public hearing on Monday, December 4, 2023, and all are invited to attend.

Robert Barron, 1104 Virginia, asked Council why tax payers cannot use the public restrooms at City Hall. PUBLIC COMMENT

Christopher McCrary, 605 Bowen, reported that there is a city tree in his yard, between the street and sidewalk, that is causing root damage to his water line and gas line. McCrary reported that he had hired a plumber because he thought he had a water leak in the yard. McCrary reports that the plumber advised him that the water leak was due to the tree roots. The tree is located in the easement between the city roadway and McCrary's property line. It was the general consensus of Council to request that work order will be issued for the Public Works Department to investigate the matter.
