

CITY OF ROCKY FORD - CITY COUNCIL MEETING

November 24, 2020

WORK SESSION: 6:00 p.m.

Mayor Susan Jung, Councilmembers Rich Geist, Jolly Rose, Cuco Ruiz, Sherri Cordova, Daryl Grasmick, Peggy Sue Corbin-Romero, City Manager Shannon Wallace and Fire Chief Rick Long met by Zoom meeting. Discussion was held regarding the Code Enforcement Officer position. Some discussion was held regarding the police academy training and the training needed for Code Enforcement. Councilmember Ruiz asked if the City could re-post the position and ask for someone that is already certified.

Discussion was held on the vacant building registry proposal. Council would like City Attorney Nathan Shultz to go ahead and draft an ordinance.

Councilmember Cordova reported that she and Duane Gurule found that there may be a grant application that could help the Grand Theater, applications are due very soon and Sherri would like to meet with Bruce Carle, the President of the Grand Theater Board, to discuss this opportunity. Discussion was held on whether or not the City of Rocky Ford can apply for the grant without going through the Grand Theater Board.

Mayor Jung mentioned that Fire Chief Ray Gonzalez needs to be appointed to the Rocky Ford Rural Fire District (RFRFPD) Board, so Councilmember Cordova will be put on the Gobin Building Board instead of the RFRFPD Board.

CITY MANAGER'S REPORT

City Manager Shannon Wallace sent her report by email to Council at an earlier date. In addition to that report as follows:

- Rick Long was scheduled to give his departmental report but he has been feeling ill and won't be reporting this evening. Police Chief Angelo Griego is still not feeling well and is out of work.
- The tobacco ordinance will be reviewed by City Attorney Nathan Schultz and he is also not feeling well. This issue will be addressed in December.
- Electronic water meter ordinance was sent by email. Council would like City Attorney Nathan Schultz to prepare an ordinance for that.
- The Hancock Well is owned by the City but more information is needed to go ahead with this issue. Some discussion
 was held. The well is on .193 acres. Councilmember Cordova will try to find out more information from the Otero
 County Assessor Ken Hood. Councilmember Grasmick moved to table this matter until more information can be
 gathered. Motion was seconded by Councilmember Geist. Voting results were:

STAFF REPORTS / MAYOR AND CITY COUNCIL REPORTS

Mayor Jung reported that Otero County was moved to the "red" level of Covid-19. Mayor Jung urged everyone to wear their mask and practice social distancing and she also wishes all a Happy Thanksgiving.

Councilmember Rose reported that she attended an Otero Partners Inc. (OPI) meeting. The Board dealt with some Care's Act funds and OPI will be a pass through for those funds. Rose also attended an Otero County Landfill, Inc.) OCLI meeting and the only business was to approve the bills.

Councilmember Corbin-Romero reported that she attended a Grand Theater Board meeting. The Grand Theater has been closed down again with the new level "red" restrictions.

Fire Chief Ray Gonzales informed Council that the Rocky Ford Rural Fire District (RFRFD) Board would like to help fund, by no more than \$50,000, the completion of three (3) rooms at the Public Safety Building. The rooms to be completed would be the conference room, fitness center room and the firefighter's bunk room. Ray did reach out and got a few bids for the work. One bid was from Stafford Customer Carpentry, LLC in the amount of \$62,025.65 and Arc Valley Construction, Inc. in the amount of \$98,567.00. Fire Chief Gonzales reported that the Public Safety Fund has approximately 72,000 that can be used for the City's portion. Councilmember Grasmick moved to approve and award the bid from Stafford Custom Carpentry, LLC to complete three (3) rooms at the Public Safety Building in the amount of \$62,025.65, with the RFRFPD covering one-half of the total cost. Motion was seconded by Councilmember Rose. Voting results were:
