Joe Ayala (Edward Jones Advisor) - Retirement Discussion

Joe Ayala reported to Council that City Attorney Bart Mendenhall and the Gold Leaf Company are working on changes to be able to move forward with One America. Discussion was held.

Letter from Shannon Wallace

City Manager Shannon Wallace asked the Council to rescind the letter of resignation she submitted as Mayor of the Town of Swink. Councilmember Grasmick asked City Manager Wallace if she would be able to recuse herself from business dealings that pertained to the City of Rocky Ford and the Town of Swink. City Manager Wallace advised Council that she would do that and that her position as mayor of the Town of Swink is a non-voting position. Discussion was held regarding time that may be spent away from the duties of City Manager of Rocky Ford. Councilmember Rose commented that she felt that Shannon Wallace being Mayor of the Town of Swink would be helpful to Rocky Ford. Councilmember Rose moved to allow City Manager Shannon Wallace to rescind the letter of resignation for the Mayor of Swink. The motion was seconded by Councilmember Ruiz. Voting results were:

<u>CITIZEN PARTICIPATION</u>

City Manager Wallace read aloud a letter from the mother of Nick Martinez requesting Council to allow chickens in backyards. Ms.Martinez reported that they plan to move to Rocky Ford and have a special needs child. The family feels that chickens are helpful in developing structure and responsibility in the life of this child. City Manager Wallace reported that she had received a petition in favor of allowing chickens, within City limits, that had about 180 signatures, but in reviewing the petition, many signatures were not Rocky Ford residents. There was much discussion regarding the thoughts of the Otero County Health Department, code enforcement and the need to hear arguments from both sides. Councilmember Grasmick recommended that this matter be a ballot question for the November election. Councilmember Grasmick moved that this matter be tabled to a later date. Motion was seconded by Councilmember Corbin-Romero. Voting results were:

STAFF REPORTS/UPDATES

Fire Chief Ray Gonzales asked Council to allow him to speak as a private citizen to ask Council for their support of the Rocky Ford Rural Fire Protection District's ballot initiatives 6A and 6B in the election on May 5, 2020. The Rocky Ford Rural Fire Protection District believes these initiatives are necessary to maintain the current level of service as well as for the replacement of worn outdated equipment and personal protection equipment for both paid and volunteer staff.

CITY MANAGER REPORT/UPDATES

City Manager Wallace reported:

- Update on where the City is at with COVID-19 procedures. Staff working hours, furloughs, swim pool outlook and summer baseball outlook. All soccer registrations were refunded. Library and Museum update.
- Revenues on tax and utilities.

Councilmember Rose reported that the Otero Partners, Inc. (OPI) chose to forgive interest on some loans during the COVID-19 pandemic and the Otero County Landfill, Inc. (OCLI) board paid bills.

Councilmember Corbin-Romero reported that the Tree Board has concerns that some trees are overgrown and are obstructing vision for drivers, especially behind Harris Pharmacy in the parking lot. City Manager Wallace commented that the City is low on funding and offered that the Public Works crew will do what they can without hiring a tree trimmer.

Councilmember Grasmick reported that there is a house on Washington that is filled with trash and that the trash tote at the Museum needs to be changed out from a 300 gallon to a 90 gallon. City Manager Wallace commented that a work order shall be done to Public Works Director Rick Long.

Councilmember Ruiz gave a shout out of thanks to Public Works Director Rick Long and his crew for doing a great job with shortened staff during this pandemic.

Mayor Jung reported that she had attended an Action 22 meeting and discussion with Senator Cory Gardner.
