

## CITY OF ROCKY FORD - CITY COUNCIL MEETING

February 25, 2020

### **WORK SESSION:**

Mayor Susan Jung and Councilmembers Rich Geist, Daryl Grasmick, Jolly Rose, Cuco Ruiz, Matthew Holland, Peggy Sue Corbin-Romero, City Manager Shannon Wallace and City Attorney Bart Mendenhall met for a City Council Work Session at 6:00 p.m. on Tuesday, February 25, 2020. Others in attendance: Public Works Director Rick Long, Volunteer Curator Emmett Davis, Rick Weiss and Tom Martin. Discussion was held regarding the City's current contract with the Chamber of Commerce regarding the Gobin Building. City Attorney Bart Mendenhall reported that he will make copies of the current agreement and distribute to Council for discussion. City Manager Wallace gave Council a report on the bills that the City pays on behalf of the Gobin Building. Public Works Director Rick Long talked to Council about water treatment.

### REGULAR MEETING:

## **APPROVAL OF MINUTES**

### **EXECUTIVE SESSION**

Following adjournment of executive session, Mayor Jung asked if any person who participated in the executive session believes that any substantial discussion of any matters not included in the motion to go into executive session occurred during the executive session, or that any improper action occurred during the executive session. No one stated any concern for the record. Council went back into regular session. No further action was taken.

## **CITIZEN PARTICIPATION**

Tom Martin asked Council what is planned or what can be done about abandoned homes in Rocky Ford. Mr. Martin feels that the abandoned property is a health, fire and hazardous concern. Tom Martin reported that he knew an investor that was interested in building an assisted living complex. The investor drove around Rocky Ford and told Tom Martin that he would not consider Rocky Ford due to all the abandoned houses.

Margarito Garcia informed Council that he has owned property in Rocky Ford for about 75 years and he feels that Rocky Ford looks horrible. Mr. Garcia reported that the trailer park on Chestnut has disassembled trailers, trash in the alley and curbs. Mr. Garcia feels that there is no civic pride in Rocky Ford.

## **CLEAR GOV DISCUSSION**

City Manager Wallace asked Council if they had given any consideration to the presentation that was given to them at the last Council meeting. Shannon reported that she has had further discussion with Ryan of ClearGov and they are willing to take the initial payment of \$7,000.00 for this year and split it into monthly payments and give the City a prorate for June through December in the amount of \$5,200.00. After this, the City would be locked in for five (5) years at \$7,000.00 per year. Discussion was held regarding the feasibility of this program and the expense when so many other issues need to be addressed with the City's money and the expenses that the City already pays for the system currently being used. Councilmember Corbin-Romero asked if any other company had been looked at for pricing comparison. No further discussion or action was taken.

# DISCUSSION REGARDING SAFETY AT PARKS

City Manager Wallace reported that CIRSA conducted a safety audit. The City was cited for Library Park and Play Park Hill because the City does not have the soft rubber mulch underneath the playground equipment. The City was also cited for Lyons and Crystal, but the City just removed all the equipment from those two places. Discussion was held about Park usage and the possibility of any grants to purchase rubber mulch.

# Discussion on Vacant Property – (Letter from Cuco Ruiz)

Councilmember Ruiz had previously offered to purchase a piece of property from the City to build a Community Garden. City Attorney Mendenhall recommended that Council get an appraisal for this property or a study of other like properties to determine the value of the property. After discussion was held, Councilmember Ruiz informed Council that he is no longer interested in this property and he recommends that Council sell it with other City properties.
