#### PUBLIC COMMENT

Museum Friends Board Member Donna Abert addressed Council to inform them of her opinion of current problems with the Rocky Ford Historical Museum. She requested that Council advise City Manager Wallace to accept a request from the Museum Board to place Rob Marshall on a six-month probation. Donna Abert reported that the Museum Board had held an executive session and the Board did not have confidence that the current Curator had the technical experience that was necessary. Donna Abert would like Council to return Jeanette Myers to the Museum Board.

### **CITY MANAGER'S REPORT**

City Manager Shannon Wallace reported to Council on the following:

- Shannon reported that there is still a lot of discussion on how the City can spend the ARPA funds. There is a lot of
  discussion going on among many people on this matter. If the City is unable to use ARPA funds, the City is not in a
  position to finish the Public Safety Building
- The City's fee schedule and vacant building registry are items that need to be discussed by Council.
- Shannon will be sending a list out to Council that details what needs to be repaired or worked on at the City's rental house.
- The agreement contract between the City of Rocky Ford and the Rocky Ford Chamber of Commerce, regarding the Gobin Building, still need to be agreed to and signed.
- Rural Fire Board Pension Board is finishing up their by-laws and will be asking Council to authorize the Mayor and the City Manager to sign.

Councilmember Grasmick reported that the Rural Fire Pension Board has been working on their by-laws and they hope to finish in about a month or so. Grasmick reports that the Otero County Landfill is looking good. Grasmick also gave a report on the potential new business for Otero County Partners, Inc. (OPI)

## Community Solar Next Steps – US Solar Presentation

The contract would be with US Solar and there would be a 15% savings to the City by connecting the City offices to this program. The location of the solar farm is in Pueblo, Colorado. Council thanked them for their presentation.

### Discussion - Disc Golf Proposal

Rob and Sammie George, owners of Good Day Disc Golf, asked Council to consider allowing him to use a portion of Play Park Hill and the Play Park Playground to set up some poles. Rob would like to have a tournament on October 9<sup>th</sup> and 10th and he has already discussed this matter with the Rocky Ford Country Club. The playground would need to be closed for the weekend, the 8<sup>th</sup> and 9th. The poles would not be on the golf course but on the playground side. Rob would provide all the signage needed to close the playground.
