

CITY OF ROCKY FORD - CITY COUNCIL MEETING

December 8, 2020

WORK SESSION: 6:00 p.m.

Mayor Susan Jung, Councilmembers Rich Geist, Jolly Rose, Cuco Ruiz, Daryl Grasmick, Peggy Sue Corbin-Romero, City Manager Shannon Wallace and Public Works Director Rick Long met by Zoom meeting. Discussion was held regarding the vacant building registry proposal. Council would like City Attorney Nathan Shultz to go ahead and draft an Ordinance for their review.

City Manager Wallace explained the budget reports regarding the Grand Theater to inform Council of where the Grand Theater stands regarding the 2020 budget.

Discussion was held regarding the City of Rocky Ford's responsibilities to the Gobin Building and what responsibilities remain with the Chamber of Commerce. A letter will be sent to the Chamber of Commerce asking to meet and discuss the Gobin Building revenues and expenses. Councilmember Grasmick commented that he believes there is money allotted for the City to use towards expenses for the Gobin Building.

Councilmembers discussed the possibility of having a "goal setting" meeting somewhere other than Council Chambers or Zoom meeting. More discussion will be held when Covid-19 restrictions are lifted.

APPROVAL OF AGENDA AND CONSENT AGENDA

Mayor Jung explained the Agenda and Consent Agenda to Council and audience. PUBLIC COMMENT

George Hanzas with the Rocky Ford BPOE Elk's Club spoke to Council about the Club's desire to section off an area that can be used as "outdoor" dining. With the current level of restrictions for COVID-19, the porch is not being used. Some discussion was held.

CITY MANAGER'S REPORT

City Manager Shannon Wallace went over the contents of her manager report with Council. In addition, discussion was held regarding:

- 1. Three employees that have returned to work after COVID quarantine.
- 2. Security system for City Hall.
- 3. Cares Act.

MAYOR AND CITY COUNCIL REPORTS

Mayor Jung reported that the Colorado Municipal League (CML) may be able to help secure grants to help with the required usage of body cameras and the storage of images for police officers.

Councilmember Rose reported that the Rocky Ford Planning Commission cancelled its meeting this month. She attended an Otero Partners Inc. (OPI) meeting. The Board is managing the business loan fund. Rose also reported that the Otero County Landfill, Inc. (OCLI) had postponed their meetings to the third Monday of the month to allow more time for information to be collected. The Library Board is looking at offering some online reading for youth.

STAFF REPORTS

Library Director Leanna Chavez gave a departmental report to Council regarding the COVID restrictions and how they are offering curbside checkout of books and other materials. Public can email any documents that they need printed, the staff will print and they can pick them up curbside. The library did receive a 2021 summer reading grant in the amount of \$4,000.

Parks and Recreation Director Stacey Milenski reported to Council that all recreation programs have been placed on hold until COVID restrictions are lifted. Some adult softball tournaments were held over the summer at Babcock Park and youth soccer and kickball programs were offered in the fall. Improvements were made at Babcock Park including a six foot fence on the middle playing field, old cinderblock dugouts were removed and replaced with chain link, old batting cage was removed and a new one was put up, painting of handicap railings and the restrooms were painted and a bench was installed for the scorekeeper. Railroad Park benches were repaired and freshly painted. Improvements at Library Park were new handicap rails, new paint at the entrance of the library, overgrown bushes and grass were cutback and debris was removed. Crew will work to remove overgrown branches from trees at Play Park Hill.

The Parks department would like to utilize the shop at the fairgrounds to store equipment and protect the equipment from weather. New signage was placed at the cemetery entrance and cemetery and parks crew are working to clean the blocks at the cemetery to prepare for the Wreath's Across America, celebrated on December 18, 2020. Crew is also cutting back the peonies to promote new growth.

Due to COVID restrictions no fairground facilities are being rented at this time and RV rental space income is running close to figures from last year.

OLD BUSINESS

Hancock Well

Public Works Director Rick Long informed Council of what he knows about the well. Much discussion was held regarding what should be done with the Hancock Well. The well has poor quality of water and is believed to have radon and selenium which makes the water not a viable source of potable water. The well has not been used since 2009, the pump and other equipment are not in good shape, the well is not adjudicated for agricultural use and has no augmentation water available. Public Works Director informed Council that the well has little to no value to anyone. Councilmember Grasmick offered to contact Brian Hancock to see if he knows anything about it. Councilmember Geist moved to table this matter to a meeting in January to allow time to gather additional information. The motion was seconded by Councilmember Grasmick. Voting results were:

Update on Public Safety Building Funds - Completion of three Interior rooms

City Manager Wallace reported that Fire Chief Ray Gonzales learned that he had significantly less funds than was previously reported to Council. The fund has \$14,670. At the November 24, 2020 Council meeting, City Council approved and authorized Fire Chief Gonzales to award a bid in the amount of \$62,025.65 to Stafford Custom Carpentry, LLC. The Rocky Ford Rural Fire Protection District (RFRFPD) was willing to pay a portion up to \$50,000.

Councilmember Grasmick withdrew his original motion made at the Council meeting on November 24, 2020 and moved to allow the usage of \$14,670 to start the completion of the three rooms at the Public Safety Building with, at least, a matching share to be made by the RFRFPD. Motion was seconded by Councilmember Geist. Voting results were:

City Manager Wallace informed Council that the Rocky Ford Rural Fire Protection District (RFRFPD) pays the City \$6,496 per year, per the agreement, to reimburse the City for what the City pays out for pensions. This money was supposed to go towards pensions. The money has been put in the general fund which covers a little over 2,000 that the City pays out. The RFRFPD reports that the difference in money should be put into the pensions. The difference has not been put into the pension fund because it was not known that it should have been done. The Rocky Ford City Auditors are not aware of this either. City Manager Wallace asked Council for guidance on what should be done. Councilmember Ruiz moved to table this matter so that further discussion can be held. Motion was seconded by Councilmember Geist. Voting results were:
