Public Works Director Rick Long has received a bid from Sole Source for repairs. Money for this project will come from Highway Users Tax Fund (HUTF) and from the 1 percent sales tax. ## Proposal for Lift Station Repairs

City Manager Shannon Wallace reported that Public Works Director Rick Long has been having issues with the west lift station. Quite a bit of time and money has been spent trying to fix the issues. On July 27, 2020, the system completely shut down and the lift station reached critical levels. SBT Electrical and Mechanical, LLC and Browns Hill have submitted bids for the repairs. The Browns Hill bid is considerably less. Both the Public Works Director Rick Long and Luke James have recommended the Browns Hill bid. Councilmember Corbin-Romero moved to approve the Brown's Hill bid if they would offer a warranty and provide a date when they could start. There was no second to the motion. The motion died. There was some additional discussion. It was moved by Councilmember Ruiz and seconded by Councilmember Geist to approve and authorize the Browns Hill bid. Voting results were:
