

CITY OF ROCKY FORD - CITY COUNCIL SPECIAL MEETING

January 29, 2021

SPECIAL MEETING: 6:00 p.m. - The purpose of the special meeting is to consider, discuss and possibly change the payment option for the vac truck and two (2) executive sessions.

Rocky Ford City Council met in special session at 2:30 p.m. on Friday, January 29, 2021 at 408 N. Main Street. Mayor Susan Jung called the meeting to order. Those present at roll call were:
