Appointment of Ward I Council Seat

Rent Increase at 1101 Lincoln

City Manager Shannon Wallace informed Council that the City currently rents this property to Jack Barker of Innovative Water Technologies and the monthly rent is \$300 which includes utilities. City Manager Shannon Wallace asked Council to consider raising the rent to \$600 per month to be effective January 1, 2021. Discussion was held regarding utilities. Council would like City Manager Shannon Wallace to provide them with more information regarding the average cost of power and gas for this rental house. City Manager Shannon Wallace will provide them with more information. No other action was taken.

Fowler Police Department Intergovernmental Agreement

City Manager Shannon Wallace informed Council that the City of Fowler would like the City of Rocky Ford to once again dispatch for them. Fowler was using the services of the Otero County Sheriff, but Otero County wants to get out of dispatching. City Manager Shannon Wallace asked Council to re-implement the previous Intergovernmental Agreement (IGA) with Fowler with the same cost of 23,000 per year and the same conditions. Some discussion was held. Councilmember Ruiz asked for a copy of the IGA prior to voting on it. Councilmember Rose moved to approve the IGA with Fowler without review. Motion was seconded by Councilmember Grasmick. Voting results were:

MAYOR & CITY COUNCIL REPORTS OR UPDATES

Councilmember Rose reported that she attended an Otero County Partner's Inc. (OPI) and Otero County Landfill, Inc. (OCLI) meeting. OPI approved a loan for a new business in Trinidad. Councilmember Rose reported that OCLI landfill has been very busy lately and the excavator is broken down and needs repairs. Discussion was held regarding out of town persons dumping shingles at the landfill and whether or not the landfill charges for that. Councilmember Rose commented that she will inquire about that at the next meeting. Councilmember Rose asked City Manager Shannon Wallace if the Liberty School would qualify for EPA. City Manager Wallace reported that she has looked into that and is waiting for a response. Councilmember Rose also asked if Otero Junior College (OJC) will be having academy this year. City Manager Wallace reported that the next enforcement academy is full and the one after that is full with a waiting list.

Councilmember Corbin-Romero reported that the Curbside Popcorn event continues to be successful and the Grand Theater had curbside popcorn the night of the fairground drive-in movie. The next curbside popcorn will be on July 31st.

Mayor Jung informed Council that she had received notice from the Colorado Municipal League (CML) that they would like to honor and recognize her for her participation with CML and reaching the CML Leadership level in CML's education program. CML awarded Mayor Jung with a \$25 certificate. Councilmembers gave Mayor Jung their congratulations. Mayor Jung also thanked City Manager Shannon Wallace for her efforts as City Manager. Mayor Jung reported that there are three (3) employees out with COVID-19 quarantine. Shifts are being covered with firefighters from around the state and local area.

Councilmember Grasmick reported that the road is very bad and in need of repairs from Hopkins Street and east to Highway 71.

Councilmember Ruiz reported that the Library Board will meet next week. Councilmember Ruiz thanked the Public Work's crew and reported that they have been working really hard.

City Manager Shannon Wallace printed and distributed copies of the IGA with Fowler to the Council. After Council had time to review the agreement, Councilmember Ruiz moved to approve the Intergovernmental Agreement between the City of Rocky Ford and the City of Fowler to provide dispatch services. The motion was seconded by Councilmember Corbin-Romero. Voting results were:
