- Barron reported that he is helping the Small Town Project with the Cinco de Mayo Fiesta planned for Saturday, May 4th at the Ark Valley Fairgrounds. A free movie will be shown, at the Grand Theater, for children (admission for the first 50 children will be paid for by Small Town Project).

- Gurulé reported that he and Interim City Manager Stacey Milenski attended a government grants program hosted by the Community Resource Center. A topic of interest was the process to apply for government and state grants.
- The Otero County Landfill will be accepting the disposal waste of the Return to Nature Funeral Home in Penrose, CO.
 The waste that will be accepted is building materials and this process will be overseen by the EPA.
- The Rocky Ford Cemetery is up for nomination to the National Register of Historic Places. The State review will be held on Wednesday and the National review will be held on May 17th.
