CITY MANAGER'S REPORT

City Manager Shannon Wallace was not present at the meeting but she had prepared a written report. Mayor Susan Jung reported the following:

- The City has received two quotes for the air/heat replacement at the Senior Citizens Center (Sage).
- Police Department would like to purchase a new radio console for their radios. The cost of the console is \$5,708. This console is very important and much needed.
- The City submitted a letter to CDPHE regarding the City's noncompliance violation. The CDPHE has accepted the City's offer letter.
- City Auditors have been conducting a "mini audit" to see if the City is on track for 2020 or if changes are needed to prepare for the 2021 budget season.
- The City employee's retirement program has successfully been changed to One America.
- Shannon attended some classes from the Colorado Municipal League's (CML) virtual conference and also attended Women Leading Colorado conference.

OLD BUSINESS

510 South 4th Street

Lisa and Ernie Montanez addressed Council regarding City owned property at 510 S. 4th Street. The Montanez's informed Council that they are interested in purchasing this property for development and they wanted to know more information about the lot size, price and if there was water and sewer availability. Some discussion was held regarding what the Montanez's plans were for the development of the lot. Mayor Jung advised the Montanez's to consult with Public Works Director Rick Long about their concerns and discussion could be held again at the next regular meeting.

Ward I Interviews and Appointment

Sherry Cordova, 302 Elm Avenue, Rocky Ford and Nicole Roberts, 800 S. 6th Street, Rocky Ford gave Council their reasons for wanting to fill the vacant Council seat for Ward I. Mayor Susan Jung informed Cordova and Roberts of how a City type of government works and the employees that report directly to the City Council. Council had a list of prepared interview questions that was asked of Cordova and Roberts.

Air/Heat - (Sage) Senior Citizens Center

Two bids have been received for a heating//air conditioning unit for the Senior Citizens Center (Sage). GSK Refrigeration's bid in the amount of \$14,917.64 and Norton HVAC's bid in the amount of \$16,850.06. City Mayor Susan Jung informed Council that she believed that City Manager Wallace was waiting for a few more bids and the Mayor requested that Council table this matter to the next meeting. It was the general consensus of Council to table the matter to the next meeting.

Police Department - Radio Console

The Rocky Ford Police Department is in need of a new radio console to properly maintain the communication equipment required for patrol and dispatch. The purchase is considered necessary and the funding will come from the salaries budgeted in 2020. The Rocky Ford Police Department has not been fully staffed for the year and the City Auditors have approved the use of these funds to buy the console. Councilmember Ruiz moved to approve and authorize the purchase of the Motorola radio console. Councilmember Geist seconded the motion. Voting results were:

Councilmember Corbin-Romero requested that a work session be held to discuss when performance reviews are due for the City Manager, City Attorney and Municipal Court Judge. Corbin-Romero also requested that the City Manager provide information on the expenditures of each department on vehicle gas and maintenance, as well as who is taking City vehicles to their homes at the end of their shift.

Mayor Jung reported that she attended the Colorado Municipal League's (CML) virtual Mayor's Mingle. The meeting topic centered on the new state regulations regarding police departments. The new regulations do not look well for small and rural departments from a financial position. CML will have a policy meeting on October 11, 2020. New laws would have a \$25,000 unprotected liability in civil suits and also that body cameras would need to be downloaded after each shift. This would increase costs involved with storage and reporting requirements to the State.

There was some general discussion about grant writers and the current situation with available grants.
